This grant was relative to a project to remove asbestos floor tile in the lower level of the Museum, put in new tile and demo the restrooms on the lower level. A new exhibit will be placed in that area. This also included the removal and disposing of existing concrete; form and our new concrete steps; remove and replace handrails with new railings that meet code; demo existing crumbling concrete at approaches beside steps at market Street; form and pour new approaches, repair disturbed ground and reseed. Cost estimate for the project is \$227,533.00. Said project will be supported by grants totaling \$120,000.00 and monies from the Allen County Historical Society in the amount of \$107,533.00. Commissioner Begg moved to allow Commissioner Noonan to sign a Cooperative Use Agreement on behalf of the Board of Allen County Commissioners. Motion seconded by Commissioner Sneary.
