	 Two (2) furnaces have failed in the Preschool Building at the Board of Education. The units are approximately 30 years old. All Temp has removed parts from one unit in order for the other one to operate. These units are paired together so we have heat throughout the building. Plan to replace the units with one high efficiency unit in the summer when school is out. The system in the ED building is identical to the once in the Preschool building and would like to replace that unit as well. Said projects have been requested in the projects listed under capital improvements. The security system at the Title Building has cellular back-up and it is no longer supported because of being a G2 system. To have the system upgrade to G3/G4 - cost would be \$2,003.12. Prosecutor's Door Acess. During installation, it was discovered there are no available licenses in 		

	 the S2 system. Northwest Security Systems has provided a quote of \$2,400.30 to purchase 16 more licenses. This will allow the completion of the Prosecutor's installation and have 13 licenses to expand in the future at any location. Schindler Elevator has submitted a change order for the jail elevator in the amount of \$9,387.00. This change order is necessary because motor shop has discovered severe damage to the armature that requires specially made parts and labor performed by a specialized motor repair facility.
