- 2. Resolution #174-18. Authorize a contract with Peterson Construction Company to perform aerator repair work at the American-Bath Wastewater Treatment Plant. Per Rick Boerger, this contract in an amount not to exceed \$42,000.00. Commissioner Berger moved for approval. Motion seconded by Commissioner Noonan. The roll was called and the resolution was approved unanimously.

1. Resolution #175-18. Enter into an Enterprise Zone Agreement with K & M Tire, Inc. and declaring the act an emergency. Per Cindy Leis, this is a 7,000 sq. ft. office expansion. This is a \$770,000.00 to a \$1.5 million investment for office space/equipment. They plan to hire ten (10) full-time employees. Currently K & M Tire employes 175 employees. This is a 60% abatement for a period of ten (10) years.
