Commissioner Noonan moved for approval. Motion seconded by Commissioner Sneary. The roll was called and the resolution was approved unanimously.
- 2. Resolution #182-18. Renew a contract with Infinisource COBRA Compliance Systems, Inc. for COBRA administrative services. This is an amount not to exceed \$3,880.00 for a period commencing March 1, 2018 through February 28, 2019. Commissioner Sneary moved for approval. Motion seconded by Commissioner Begg. The roll was called and the resolution was approved unanimously.
- 3. Resolution #183-18. Authorize the purchase of two (2) 2018 International HV 507 Truck Chassis's from Rush Truck Center of Ohio through the State of Ohio Cooperative Purchasing Program. Per Nathan Davis, this is request for drainage easements and work agreements south of Breese Road. The easements are with Metz Vets Facilities and JB Real Ventures, LLC. Commissioner Noonan moved for approval. Motion seconded by Commissioner Sneary. The roll was called and the resolution was approved unanimously.

3. Resolution #186-18. Accept proposal and enter into contract with M.P. Dory Company for the Guardrail Safety Improvement Project. Per Dave Louth, two (2) bids were received with the low bid being M.P. Dory Company in the amount of \$296,720.13. This project will be federally funded. Funding is capped at \$300,000.00. Commissioner Sneary moved for approval. Motion seconded by Commissioner Begg. The roll was called and the resolution was approved unanimously. Brion Rhodes, Allen County Engineer, stated that after a recent bridge inspection on Wentz Road, Monroe Township, they have found that a "Road Closed" posting is needed. This bridge was built in 1965 and in 2006, the county started seeing issues with the bridge. In 2017, the load limit was lowered to 15 ton due to deterioration. Resolution #187-18. Authorize the County Engineer to remove a fifteen (15) Ton Gross Load Limit and post a "Road Closed" for the Wentz Road Bridge, No. MON-TR,257-0.74, Monroe Township.
