	Commissioner Sneary opened the meeting and swore-in those that might provide public testimony.

The Report of the County Engineer was read into record. Brion Rhodes, Allen County Engineer, stated that an easement needed to be maintained for future development of the proposed vacated site. Once vacated, the easement would be hard to obtain. Commissioner Sneary noted the filing of an objection from Hunt & Johnson. Kelly Temple and Valerie Wilmoth provided testimony in favor of the Sprague Blvd. vacation. Thom Mazur, Lima-Allen County Regional Planning Commission, provided testimony as to why vacation should not proceed. Ralph Haggard stated that it would be a detriment if vacation would go through. Brion Rhodes, Allen County Engineer, added that the county prefers multiple access points adjacent to the subdivision and potential development. Does not see benefit to vacate. James Hecht stated that if the land is developed, all traffic would go through the subdivision. Jerry Johnson provided testimony as to why vacation should not proceed (as outlined in objection from Hunt and Johnson) Cordell Wilmonth stated the vacation would be a benefit. Would not like to see additional access. **Resolution #683-18.** Consider the vacation of Sprague Blvd., 0.239 acres more or less, Shawnee Township, petitioned for by Michael R. and Klly L. Temple. Commissioner Sneary moved to deny the petition for the vacation of Sprague Blvd. Motion seconded by Commissioner Begg.
