- 1. Notice to Legislative Authority Ohio Division of Liquor Control D2 permit Zinum 12 LLC dba 12 East Request a Hearing / Do Not Request a Hearing. Commissioner Noonan moved to not request a hearing. Motion seconded by Commissioner Begg. The roll was called and was approved unanimously.
- 2. Notice to Legislative Authority Ohio Division of Liquor Control C1, C2 and D6 permit Bradley Wright dba Pony Keg Request a Hearing / Do Not Request a Hearing. Commissioner Begg moved to not request a hearing. Motion seconded by Commissioner Noonan. The roll was called and was approved unanimously.
- **3. Resolution #691-19A.** Rescind Resolution #691-19, terminate the Allen County Health Insurance Opt-Out Incentive Program effective calendar year 2020.

Commissioner Noonan moved for approval. Motion seconded by Commissioner Begg. The roll was called and the resolution was approved unanimously.

- 4. Resolution #736-19. Authorize the purchase of a 2017 Chevy Express 2500 Van for the Allen County Sheriff's office. This is in the amount of \$21,783.00. Commissioner Begg moved for approval. Motion seconded by Commissioner Noonan. The roll was called and the resolution was approved unanimously.
- 5. Resolution #737-19. Enter into a one (1) year lease agreement with Tom Ahl Chrysler for the lease of a 2018 Jeep Grand Cherokee for the Allen County Sheriff's office. Said lease will be paid through the FOJ funds. Commissioner Noonan moved for approval. Motion seconded by Commissioner Begg. The roll was called and the resolution was approved unanimously.
- 6. Resolution #722-19A. Amend Resolution #722-19, renew Participation Agreement with County Employee Benefit Consortium of Ohio, Inc. (CEBCO) and approve Summary of Benefits. This is a three (3) years contract set to expire December 31, 2022. Commissioner Begg moved for approval. Motion seconded by Commissioner Noonan. The roll was called and the resolution was approved unanimously.
- 7. Resolution #738-19. Accept payment from Traveler's Insurance for an accident involving a 2018 Ford Explorer at the Allen County Sheriff's office. The check is in the amount of \$5,000.00. Commissioner Noonan moved for approval. Motion seconded by Commissioner Begg. The roll was called and the resolution was approved unanimously.
- 8. Resolution #739-19. Appoint Doug Olson to the Lima-Allen County Regional Transit Authority Board of Trustees. This appointment is to replace the unexpired term of Dave Stratton. Term shall be effective immediately and expire October 14, 2020. Commissioner Begg moved for approval. Motion seconded by Commissioner Noonan. The roll was called and the resolution was approved unanimously.

### DISCUSSION:

# A. Department of Job and Family Services

- 1. Resolution #513-19A. Amend Resolution #513-19, authorize the Allen County Department of Job and Family Services to purchase office furniture from K-Log and Friends Office Supply. Per Josh Parker, the agency has federal grants available to apply costs for the purchase of additional office furniture (office client chairs, dollies and waiting room furniture) from Friends Office Supply in an amount not to exceed \$20,000.00.

  Commissioner Noonan moved for approval.

  Motion seconded by Commissioner Begg. The roll was called and the resolution was approved unanimously.
- 2. **Resolution #740-19.** Authorize a contract between the Allen County Department of Job and Family Services and S & D Top Notch Painting for paint, material and labor services.
- **3. Resolution #741-19.** Authorize a contract between the Allen County Department of Job and Family Services and Blacktop Sealing, Inc. for material and labor services.
- **4. Resolution #742-19.** Authorize a contract between the Allen County Department of Job and Family Services and Alltree Tree Service for material and labor services.

Per Josh Parker, Resolution #740-19 is for the painting of the green steel structure in the front of the building. Resolution #741-19, is for the repair, sealing and striping of the parking lot closes to SR 65 on the east side of the building. Resolution #742-19 is for tree, bush and mulch removal and the replacement of river rock. Commissioner Begg moved to approve Resolutions #740-19, #741-19 and #742-19. Motion seconded by Commissioner Noonan. The roll was called and the resolutions were approved unanimously.

**5. Resolution #743-19.** Authorize a contract extension between the Allen County Department of Job and Family Services and Black & White Cab Company.

- **6. Resolution #744-19.** Authorize a contract extension between the Allen County Department of Job and Family Services and Right At Home.
- **7. Resolution #745-19.** Authorize a contract extension between the Allen County Department of Job and Family Services and K & P Medical Transport.

Per Josh Parker, this is an extension of the transportation contracts for a period of one (1) year. Commissioner Noonan moved for approval of Resolution #743-19 thru #746-19. Motion seconded by Commissioner Begg. The roll was called and the resolutions were approved unanimously.

9. Resolution #747-19. Authorize a contract extension between the Allen County Department of Job and Family Services and Fishel Downey Albrecht and Riepenhoff. Per Josh Parker, this is an increase to the contract of \$5,000.00 for an amount not to exceed \$10,000.00.

Commissioner Begg moved for approval. Motion seconded by Commissioner Noonan. The roll was called and the resolution was approved unanimously.
