1. Resolution #368-21. Approve Change Order #1 with M.P. Dory Co. for the Guardrail Safety Improvement Project. Commissioner Seibert moved for approval. Motion seconded by Commissioner Winegardner. Per David Louth, Allen County Engineer's office, the county received a \$300,000.00 100% grant for said project. The original bid was \$257,504.01. Said change order is for additional work for a final contract not to exceed \$280,235.75. The county has been approved for the 4th round of funding which will be received in two (2) years. The roll was called and the resolution was approved unanimously.

B. Department of Job and Family Services

Approve a lease agreement between the Allen County Department of Job and Family Services and the State of Ohio for the lease of office space at 951 Commerce Parkway, Lima, Ohio. Commissioner Noonan moved for approval. Motion seconded by Commissioner Seibert. Per Joe Patton, Department of Job and Family Services, this is a lease agreement with the State Auditor's for a period of one year July 1, 2021 thru June 30, 2022 at a cost of \$13,556.16. The
