This amendment is to replace Lt. Grigsby with Lt. Coil. The roll was called and the resolution was approved unanimously.
- 3. Resolution #916-21. Approve a Collective Bargaining Agreement between the Allen County Child Support Enforcement Agency and the Communication Workers of America Local 4319. - **4. Resolution #917-21.** Resolution authorizing creation of special revenue fund for purpose of accumulating resources for the payment of accumulated sick leave and vacation leave upon the termination of employment or retirement of officers and employees of the County, and

for the purpose of accumulating resources for payment of salaries during any fiscal year when the number of pay periods exceeds the usual customary pay periods, pursuant to R.C. 5705.13(B). Commissioner Seibert moved for approval. Motion seconded by Commissioner Winegardner.

5. Resolution #919-21. Approve Allen County Family Children First Council to apply for additional funding through the Ohio Department of Developmental Disabilities under the Early Intervention Service Coordination Grant. Commissioner Winegardner moved for approval. Motion seconded by Commissioner Noonan. Per Carole Enneking, Family and Children First Council Coordinator, this service has negatively been affected by COVID. The original grant was based on prior year needs and number of children served. Allen County had 107 children served in 2019. In 2020 and 2021, under 50 children were served. For FY'22, an application is being submitted to serve 50 additional children as well as provide parent education folders for the families. Total request is \$10,850.00. The roll was called and the resolution was approved unanimously.
