- 1. Resolution #194-22. Appoint delegates and alternates to the Lima-Allen County Regional Planning Commission Board. Commissioner Winegardner moved for approval. Motion seconded by Commissioner Seibert. Kelli Singhaus will replace Susan Wildermuth. The terms for the delegates and alternates is 2 years. The roll was called and the resolution was approved unanimously.
- 2. Resolution 195-22. Authorize the issuance of a maximum principal ditch improvement special assessment general obligation bond. Commissioner Seibert moved for approval. Motion seconded by Commissioner Noonan. This bond is for the Smith Ditch Improvement Project and is to establish the fund and secure financing. The roll was called and the resolution was approved unanimously.

#### DISCUSSION:

## A. Department of Job and Family Services

- 1. Resolution #196-22. Approve a contract between the Allen County Department of Job and Family Services and Croy's Mowing. Commissioner Noonan moved for approval. Motion seconded by Commissioner Winegardner. This contract is for mowing at the DJFS location and along Commerce Parkway. The roll was called and the resolution was approved unanimously.
- 2. Resolution #197-22. Approve a Memorandum of Understanding between the Allen County Department of Job and Family Services/Ohio Means Jobs and the Lima Chamber of Commerce for Top Tier Workforce Partnership. Commissioner Winegardner moved for approval. Motion seconded by Commissioner Seibert. This MOU allows DJFS an advisory role on the Chamber council Funding will be supplied through Business Service dollars. The roll was called and the resolution was approved unanimously.

## B. Child Support Enforcement Agency

1. Resolution #198-22. Authorize the Allen County Child Support Enforcement Agency to renew a lease agreement with Quadient Leasing. Commissioner Seibert moved for approval. Motion was seconded by Commissioner Noonan. This is a renewal lease, with a cost savings of \$1,953.00 over the life of the lease. The roll was called and the resolution was approved unanimously.

## C. West Central Ohio Land Conservancy

1. Resolution #199-22. Resolution of support for an Agricultural Easement Purchase Program Application. Commissioner Noonan moved for approval. The motion was seconded by Commissioner Winegardner. Commissioner Winegardner noted a mistake in wording on the resolution, and the Assistant Clerk made note to correct before Commissioners signatures. This applicant for an agricultural easement purchase program is located in Amanda Township. The roll was called and the resolution was approved unanimously.

### D. County Engineer

- 1. Resolution #200-22. Approve an estimate of material and labor necessary for the replacement of the superstructure on Grismore Road. Commissioner Winegardner moved for approval. Motion seconded by Commissioner Seibert. This is for a new concrete deck on the Grismore Road structure located in Richland Township. The estimated cost is \$79,289.26. The roll was called and the resolution was approved unanimously.
- **2. Resolution #201-22.** Set date, time and place for a view and hearing for the establishment of Stemple Road, located in Jackson Township, Allen County, Ohio pursuant to Section 5553.04, O.R.C. Commissioner Seibert moved for approval. Motion seconded by Commissioner Noonan. This road has never formerly been established. Jackson Twp. Trustees have requested for the road to be established. The view will be on April 5, 2022 at 2:30 p.m. at the intersection of Stemple Rd. and Bentley Rd. The hearing will be held on April 14, 2022 at 11:00 a.m. in the Allen County Commissioner's office, located at 204 N. main Street, Suite 301, Lima, Ohio 45801. The roll was called and the resolution was approved unanimously.
