You may also submit a sealed bid on a form available at the Office of the Allen County Commissioners, in lieu of attending in person. All absentee bids shall be opened at the time and place of sale, shall be available for inspection and review by all bidders then present in person, prior to final bids being submitted to and reviewed by County Personnel for acceptance and termination of the auction proceedings.

The Board of Commissioners reserves the right to reject any and all bids.

The opening bid shall be a minimum of \$10,000.00 with minimum bid increments thereafter of at least \$100.00.

The bid will be awarded to the highest bidder. Final closing shall occur, and the balance of the purchase price paid, if any, within thirty (30) days thereafter, at the office of the Allen County Commissioners, as aforementioned, or as otherwise mutually agreed. The winning bidder shall pay a deposit of \$1,000.00, which represents 10% of the minimum bid amount, the day of the auction in cash or by cashier's check. At final closing, the winning bidder shall receive a quitclaim deed from the Allen County Commissioners.
