Bids will be received by the Clerk of the Board of Allen County Commissioners and will be opened by the clerk of said County, on **Thursday, May 25th, 2023 at 11:15 A.M.** Bids will be for the rehabilitation of the Conant Road Bridge No. MAR-046-0.79, over Flat Fork in Marion Township; Allen County, Ohio; the rehabilitation of the said bridge will require hydrodemolition of the bridge deck and overlaying with latex modified concrete, installation of a polymer modified expansion joint system at the abutments; and construction of all approach work including grading, paving and seeding. The project length is 315.6 linear feet.

Each bidder is required to furnish with its proposal a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must provide evidence of its experience on projects of similar size and complexity. The owner intends and requires that this project be completed no later than **November 1, 2023**.

All contractors and subcontractors involved with the project will to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123 is required.

Bidders must comply with the prevailing wage rates on Public Improvements in Allen County, Ohio as determined by the Ohio Department of Commerce, Bureau of Wage and Hour Administration, 614.644.2239.
