- -Update on One River Front Project
- -Discussion on OneOhio Funds
- Commissioner Noonan provided an update on the timeline for the Administration Building Project -Discussion on placement of the building on the site and traffic control during demolition and construction
- Discussion on proposed Cable Road Project
 -Kurt Neeper provided the reasoning for wanting to make improvements to the area due to a high rate of crashes
 - -has made an application and were approved funds through ODOT Safety Program
 - -provided an overview of the planned project to help eliminate crashes in the area which would include a raised median and an addition of sidewalks
 - -discussion on limited right-a-way space for the project and the costs to obtain commercial easements, which can be cost prohibitive to projects
 - -Average Daily Traffic numbers have decreased over the years and takes the road below the requirement of a four (4) lane road
 - -discussion on reducing/combining the amount of drives along Cable Road
 - -proposed plan does include minimizing a section of the four (4) lane road to a two (2) lane road and installation of new signalization
 - -currently reviewing and responding to comments received during the comment period from the March 21st Public Meeting and will plan to have a new proposal addressing the received concerns in late May or June
- Kurt Neeper provided an update on the Aquatic Park Project
 - -currently under construction and everything is going well
 - -appreciate the partnership with the County
 Health Department with help working through
 some items with the Ohio Department of Health
 -currently working on the endowment—proposed
 \$5M and looking into other means to reduce
 programming costs i.e. solar array
- Mayor Smith stated that a solar array will be placed at Twin Lakes to help offset utility costs
- Commissioner Seibert provided an update on Opioid Settlement and regional OneOhio funds

- discussion on collaboration with multiple entities working together to create applications for regional OneOhio funds
- -Tammie Colon, Mental Health Services and Recovery Board, has been working on completion the applications for 10 projects
- -Commissioner Seibert provided an overview of the Commissioners providing funds in the amount of approximately \$200,000.00 to match funds for some of the applications
- -Mayor Smith noted that due to the City of Lima receiving less funds, it made sense to collaborate to combine funds with the group to be able to provide services for Lima-Allen County
- -Commissioners will be appropriating their match funds tomorrow by resolution
- -Commissioner Noonan discussed what the Commissioners plan to utilize the opioid settlement funds that the county will receive in the future—would like to use funds to help with implementation of Vivitrol and transitioning those incarcerate in the jail back into the community
- -Commissioner Winegardner provided an overview of counseling available within the jail as well as the implementation of a Navigator through Mental Health Services and Recovery Board to also help with transitioning of those incarcerated back into the community
- -Mayor Smith commends the Sheriff, medical team and Mental Health Services and Recovery Board for their collaboration for implementing this
- -Commissioner Winegardner notes that a large focus of the county jail is rehabilitation, and implementing the Vivitrol and Navigator will help with that
- -Discussion on application to regional OneOhio for Lighthouse to be utilized for a coordinator and programmatic services to offer social events and a safe place for those in recovery and reconstruct their lives
- Mayor Smith discussed working with the County Auditor ad attempting to obtain Brownfield Funds -will be having a meeting next month to discuss Brownfield projects
- Mayor Smith provided an update on One River Front Project
 - -currently receiving RFP's for ideas of the location -also working with other entities on ideas for the space

	-potentially looking into an outside market Jamie Dixon provided an update on City Council -will be reviewing the City Charter and will be placing on the ballot -will be reviewing the definition of family for the City of Lima and those inhabiting one household on August 29 th Derry Glenn discussed upcoming events -First Annual Kids Mental Health event will be held this weekend -discussion on Neighbors Helping Neighbors Program Council Thompson will soon be speaking on a panel for Coalition of Homelessness in Ohio Chief Hefner discussed the plan of constructing a new Fire Station -discussion on great teamwork within the county departments Chief Cortez invited all to Police Week Memorial program -discussion on ceremony for the burying of a time capsule at the Police department -time capsule will be opened in 2087 Provided an update on the collaboration of City of Lima/Allen County Health and Wellness Expo Mike Caprella noted that the reservoirs are full due to the amount of rain received lately Mayor Smith expressed appreciation to all three Commissioners for the collaboration between the City of Lima and the Commissioners
