

# ADVERTISEMENT NOTICE TO BIDDERS

Sealed bids will be received at the office of the Board of Allen County Commissioners; Court of Appeals Building, 3<sup>rd</sup> Floor; 204 North Main Street; Lima, Ohio 45801, until 11:00 A.M., December 9, 2016, at which time they will be opened and publicly read aloud. Bids will be for the removal of the superstructure of the Central Avenue Bridge No. ALL-ML 504-0.30, over the Ottawa River in the City of Lima; Allen County, Ohio; the replacement of the said superstructure with a two (2) span, composite prestressed concrete box beam superstructure (spans being 65'-9 1/8" and 66'-5 1/2" with a 18° right forward skew) on re-used and semi-integral modified abutments and reused pier; 30'-0" f/f curb with 5'-0" sidewalks; and construction of all approach work including grading, paving and construction of all necessary drainage facilities. The project length is approximately 230 linear feet.

Bids will be accepted only from **Contractors** who perform at least 50% of the cost of the project and are prequalified for that work with the State of Ohio, Department of Transportation, per Section 102.01 AS MODIFIED HEREIN, of the State of Ohio, Department of Transportation Construction and Material Specifications, dated January 1, 2013. **Subcontractors** must also be prequalified unless they perform 15% or less of the total bid. Further requirements are listed in the Instructions to Bidders.

No contract shall be entered into unless the bidder possesses a valid Certificate of Compliance with Affirmative Action Programs, issued by the State EEO Coordinator, Certification Section, 77 South High Street, 24<sup>th</sup> Floor, Columbus, Ohio 43215, dated no later than 180 days prior to the fixed bid opening date.

Each bidder is required to furnish with its proposal, a Bid Guarantee and Contract Bond in accordance with Section 153.54 and 153.571 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the Proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity and a complete listing of all subcontractors to be used. The owner intends and requires that all work embodied in this Proposal, together with all additions will be completed by the Contract Completion Date **AUGUST 1<sup>ST</sup>, 2017.**

Bidders must comply with the prevailing wage rates on Public Improvements in Allen County, Ohio as issued by the Ohio Department of Commerce, during the life of this Contract.

All bids shall be sealed and addressed to the **Board of Allen County Commissioners; Court of Appeals Building, 3<sup>rd</sup> Floor; 204 North Main Street; Lima, Ohio 45801** and marked "**SEALED BID – ALL-**

**ML 504-0.30; PID NO. 97432**” on the outside of the envelope. The Schedule of Unit Prices form (pages 12-13 of the bid documents) shall be submitted with the bid proposal, but shall also be stored electronically on a USB flash drive, CD or DVD and submitted within the sealed bid package. Ohio Revised Code Section 9.31 allows certain conditions where a bid may be withdrawn. Notice of a claim of right to withdraw such bid must be made in writing filed with the contracting authority within two business days after the conclusion of the bid opening procedure.

The Board of County Commissioners, Allen County, Ohio reserves the right to reject any or all bids submitted or to waive any irregularities pursuant to Section 9.31 of the Revised Code.
