Sealed bids will be received at the office of the Board of Allen County Commissioners, Allen County Courthouse, City of Lima, Ohio, until 11:00 A. M., July 11, 2017, at which time they will be opened and publicly read aloud. Bids will be for the removal of all existing pavement and base, widening of the turning radii and edge of pavement along Kill Road and a section of State Road in Marion Township, Allen County, Ohio. The project includes reconstructing the roadway with an average thickness of 1.25" of 448 polymerized asphalt concrete, type 1H, PG-70-22M, to match the new width of the entire roadway. A tack coat and 1.5" of 448 asphalt concrete intermediate course will be applied on the entire roadway and 3.5" of 301 bituminous aggregate base will also be applied to the entire roadway before resurfacing. The existing sub-base may need to be cut or filled along the entire length of the project, per plan specification. 448 Asphalt Concrete shall have a bitumen content of 6.2% and may contain a maximum of 10% recycled material. Aggregate to be used in hot mix shall be stockpiled, for sampling by county and testing at least two weeks before being used in hot mix. Stone stockpiles not passing Allen County Engineer's specifications as result of testing, shall be rejected for use in this contract. The total project length is approximately 2,641 feet all of which make up the Kill Road Reconstruction Project. Included is the installation of sub-grade compaction, aggregate base, catch basins, storm sewers and pavement markings.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Allen County, Ohio as determined by the Ohio Department of Industrial Relations.

Construction plans, Specifications, and Contract Documents may be obtained at no charge from our website at www.allencountyohengineer.com/projects.

Each bidder is required to furnish with its proposal, a Bid Guarantee and Contract Bond in accordance with Sections 153.54 and 153.571 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must provide evidence of its experience on projects of similar size and complexity, and a complete listing of all subcontractors to be used. The owner intends and requires that this project be completed no later than **September 15, 2017**.

All bids shall be sealed and addressed to the Board of Allen County Commissioners; Court of Appeals Building, 3rd Floor; 204 North Main Street; Lima, Ohio 45801 and marked **“SEALED BID – KILL ROAD RECONSTRUCTION PROJECT”** on the outside of the outer most envelope.

The Schedule of Unit Prices form (pages 8-9 of the bid documents) shall be submitted with the bid proposal, but shall also be stored electronically on a USB flash drive, CD or DVD and submitted within the sealed bid package. An electronic copy of the Schedule of Unit Prices can be found with the plans and bid documents on our website at www.allencountyohengineer.com/projects.

No bidder shall be permitted to withdraw its bid for a period of thirty (30) days after the time of bid opening.

The Board of Allen County Commissioners, Allen County, Ohio reserves the right to reject any or all bids submitted or to waive any irregularities pursuant to Section 9.31 of the Revised Code.
