NOTICE TO BIDDERS**

Sealed bids will be received at the office of the Board of Allen County Commissioners, Allen County Courthouse, City of Lima, Ohio, until 11:00 A. M., August 18, 2017, at which time they will be opened and publicly read aloud. Bids will be for the reconstruction of the existing roadway in Perry Township by means of removing the existing concrete pavement and replacing with a new sub-base, stone base, asphalt base course and 448 asphalt finish course. The finish course will consist of a 1” thick course of 448 asphalt concrete so as to obtain a 1/4” per foot cross slope in the pavement. Reconstruction will match existing pavement width. The existing sub-base may need to be cut or filled along the entire length of the project, per plan specification. 448 Asphalt Concrete shall have a bitumen content of 6.2% and may contain a maximum of 10% recycled material. Aggregate to be used in hot mix shall be stockpiled, for sampling by county and testing at least two weeks before being used in hot mix. Stone stockpiles not passing Allen County Engineer’s specifications as result of testing, shall be rejected for use in this contract. The total project length is approximately 725 feet all of which make up the Roschman Avenue – Motel Avenue Reconstruction OPWC Project, an Issue 1 funded project. Also included in the project are 1,450 feet of combination curb and gutter. Catch basins will also be replaced, but most of the existing storm sewer lines, sanitary sewer and water lines will remain intact.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor’s Executive Order of 1972, and Governor’s Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Allen County, Ohio as determined by the Ohio Department of Industrial Relations.

Construction plans, Specifications, and Contract Documents may be obtained at no charge from our website at www.allencountyohengineer.com/projects.

Each bidder is required to furnish with its proposal, a Bid Guarantee and Contract Bond in accordance with Sections 153.54 and 153.571 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must provide evidence of its experience on projects of similar size and complexity, and a complete listing of all subcontractors to be used. The owner

intends and requires that this project be completed no later than **October 27, 2017**.

All bids shall be sealed and addressed to the Board of Allen County Commissioners; Court of Appeals Building, 3rd Floor; 204 North Main Street; Lima, Ohio 45801 and marked “**SEALED BID - ROSCHMAN AVENUE – MOTEL AVENUE RECONSTRUCTION PROJECT**” on the outside of the outermost envelope.

No bidder shall be permitted to withdraw its bid for a period of thirty (30) days after the time of bid opening.

The Board of Allen County Commissioners, Allen County, Ohio reserves the right to reject any or all bids submitted or to waive any irregularities pursuant to Section 9.31 of the Revised Code.
