The following legal notice is to receive bids for the installation of approximately 2911 L.F. of 2" pressure collection system installed by HDD, seven 2" valves with boxes, four flush stations and the supply and delivery only of 15 E-One grinder pumps.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Allen County, Ohio as determined by the Ohio Department of Commerce, Division of Industrial Compliance.

Plans and project documents are available at the Allen County Sanitary Engineer's Office, 3230 N. Cole St., Lima, OH 45801 for a fee of **\$25.00**. For this project, bids will be received and accepted in a sealed envelope properly marked "Slabtown & Bluelick Roads Sewer" on the outside of the envelope and submitted to the Clerk of the Board of Allen County Commissioners, 204 N. Main Street, Suite 301, Lima, OH 45801, prior to the bid opening.

Bids will be received by the Clerk of the Board of Allen County Commissioners and will be opened by the Clerk of said County, on **Thursday, June 27, 2024 at 3:00 P.M.** at the office of the Board of Allen County Commissioners, 204 N. Main Street, Suite 301, Lima, OH 45801.

Each bidder is required to furnish with its proposal, a Bid Guarantee and Contract Bond in accordance with Sections 153.54 and 153.571 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must provide evidence of its experience on projects of similar size and complexity, and a complete listing of all subcontractors to be used. The owner intends and requires that this project be completed no later than **November 1, 2024**. To allow proper time for the paperwork to be processed, the contractor will not commence work before July 15, 2024.

No bidder shall be permitted to withdraw its bid for a period of thirty (30) days after the time of bid opening.

The Board of Allen County Commissioners, Allen County, Ohio reserves the right to reject any or all bids submitted or to waive any irregularities pursuant to Section 9.31 of the Revised Code.
