Within these limits, the approximately 29 foot wide road will be milled at a depth of 4" and paved with two courses of asphalt.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Allen County, Ohio as determined by the Ohio Department of Commerce, Division of Industrial Compliance.

Bids will be received by the Clerk of the Board of Allen County Commissioners and will be opened by the Clerk of said County, on **Thursday, May 1, 2025 at 11:00 A.M.** at the office of the Board of Allen County Commissioners, 204 N. Main Street, Suite 301, Lima, OH 45801. Bids will be accepted only from Contractors who perform at least 50% of the cost of the project and are prequalified for that work with the State of Ohio, Department of Transportation, per Section 102.01 AS MODIFIED HEREIN, of the State of Ohio, Department of Transportation Construction and Material Specifications, dated January 1, 2023. Subcontractors must also be prequalified unless they perform 15% or less of the total bid. Further requirements are listed in the Instructions to Bidders.

Each bidder is required to furnish with its proposal, a 10% Bid Guarantee and Contract Bond in accordance with Sections 153.54 and 153.571 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must provide evidence of its experience on projects of similar size and complexity, and a complete listing of all subcontractors to be used. The owner intends and requires that this project be completed no later than **September 30, 2025**.

No bidder shall be permitted to withdraw its bid for a period of thirty (30) days after the time of bid opening.
